

Privacy Policy

This Privacy Policy ("Policy") applies to Facebook, Instagram, LinkedIn, and GEERS Exceptional Education Center ("Company") and governs data collection and usage. Collection of your Personal Information

- Enable solely internal uses that are reasonably aligned with your expectations based on your
